Voting via the Scrutineer*" in the Invitation to Vote).

This voting form may only be used in the case of voting directly via the scrutineer. The following information therefore only applies in the case of voting directly via the scrutineer.

Noteholders who wish to cast their vote directly to the scrutineer must do so within the voting period beginning on Tuesday, on 10 February 2026, at 00:00 (CET) and ending on Thursday, 12 February 2026, at 24:00 (CET) ("**Voting Period**") in text form within the meaning of Section 126b of the German Civil Code (*Bürgerliches Gesetzbuch – "BGB"*) to the notary Dr. Matthias Horbach, whose office is located in Frankfurt am Main ("**Scrutineer**"). Votes that are not received by the Scrutineer within the Voting Period, i.e. too early or too late, will not be counted.
